VESSEL PROCUREMENT

During the initial stages of a requirement, Colebrook Offshore will lead the commercial approach to market on an exclusive basis. At this stage, the project will be assigned a dedicated chartering manager to oversee the vessel procurement process on your behalf.

Also, to ensure you are fully informed of the market status, you will be provided with monthly CTV (currently North/Baltic Sea, Taiwan and USA) and W2W (currently North/Baltic Sea) reports, as well as a yearly market forecast report covering CTVs, W2W & Heavy Lift.

When there are requirements for support for either tendering or an immediate vessel requirement, both the assigned chartering manager and the operational support from OOL will work alongside your team to ensure we understand your requirement both commercially and operationally.

COMMERCIALLY
